**Children in Special Circumstances:

The Eastern Deanery Strategy**

What have we done?

- We have developed a syllabus for GP education as it relates to child protection and children in special circumstances*.

How have we done this?

The syllabus has been constructed and modified in response to:

- A review the literature and policy (this can be accessed on www.easterngp.co.uk).
- Discussion with health professionals and health services managers.
- One to one interviews with 'experts'.
- A questionnaire study to validate the learning objectives. This study has involved GP trainers, GP registrars, Course Organisers, GP Tutors and Primary Care Tutors and Named GPs and Designated Doctors and Nurses.

Also:

- We have provided educational and other supporting material on the deanery web site. This can be freely accessed, copied, used and modified. The educational material has been 'road tested' and modified in response to learners' views.

What next?

Initially, we want to concentrate on two main areas:

- Supporting and developing the role of the named GP
- Supporting and developing GP registrar education in child protection and children in special circumstances

What are we going to do?

We wish to engage with and network Named GPs. We will contact all the Named GPs in the deanery area and

- Invite Named GPs place their contact details on the deanery data base
- Invite Named GPs to participate in an email discussion group
- Explore and support the educational needs of Named GPs

We wish to support GP registrar education in child protection and children in special circumstances by

- Linking Named/Designated doctors/Named GPs with Course Organisers/GP Tutors/Primary Care Tutors
- Providing educational material
- Supporting sessions in the VTS

*Children in special circumstances' is a new term adopted by the National Service Framework (NSF) (<http://www.doh.gov.uk/nsf/children.htm>) to cover 'a variety of groups of children whose particular circumstances will often lead to them achieving poorer outcomes'. It includes children in need and children in need of child protection but also includes other vulnerable groups, such as: children living away from home; those looked after by local authorities; children in trouble including young offenders in institutions; asylum seeking children; children with troubled parents, such as those substance misusing or with alcohol problems; and young parents.
