# New WPBA transition arrangements

## **'New'**

- Started 5.8.20
- All trainees need to be on the new WPBA programme within two years of 05.08.2020
- All ST1s starting August
- Change training year e.g. ST1-ST2

## **'Old'**

- In any training year if the trainee has passed the mid-point of that training year it is recommended they stay on the 'old' programme.
- Extensions
- Targeted

# WPBA Requirements for every training year

## Beginning of each Placement

- Meeting with CS for placement planning meeting – complete placement planning learning log
- A PDP for each placement

# During Placement

- 3 clinical case reviews per month
- 1 other learning log entry per month
- Complete assessments regularly throughout placement

# Towards end of Placement

- Meet with clinical supervisor to complete CSR
- Complete PDP for placement

# During each calendar year –need to complete

- BLS or equivalent and AED
- Child safeguarding level 3 - if any posts during the year included children
- Adult safeguarding level 3
- Learning event analysis and (Significant event analysis if applicable)
- Reflection on involvement in quality improvement activities

# Mid Year - approximately 6 months into each calendar year

- Arrange meeting with ES for interim ES review— complete review paperwork prior to meeting

# End of year prior to ARCP

- Arrange meeting with ES for ES review– complete review paperwork prior to meeting and any outstanding PDPS and action plans prior to review
- Attach Urgent Unscheduled Care log if contractually required
- Add Form R / SOAR or equivalent to learning log
