#### Doctrine of Double Effect

St Thomas Acquinas

- 1) The Act MUST be morally good
- 2) The negative outcome is not intended, but is simply known as a natural consequence of the intended good
- 3) The good effect must flow from the action causal link
  - Emmanuel Kant
- 4) The good must outweigh the bad
- This has been accepted into English Law
  - Self defence
  - End of life medications

### Legal Background

- Suicide
  - 1961 decriminalized suicide
  - Prosecution individual / family
- Assisted Suicide
  - Part of the process of decriminalizing suicide introduced crime of aiding/abetting
  - Basis for most euthanasia discussion
  - Few acts whereby a second party may be guilty, perpetrator committed no crime

### Case Law: Self determination

- Bland
  - Hillsborough
  - PVS
- Re T
  - Sectioned
  - Gangrenous leg
  - Believed Professor Vascular surgery, refused amputation

### Case Law 2: Self Harm

- R v Brown
  - Personal consent to injury
- ► Re B
  - Switching off the ventilator

## Case Law 3: Clarity

- Pretty
  - MND
  - DPP none prosecution agreement
- Purdy
  - MS
  - Clarification from DPP

#### Director Public Prosecutions


- Head of the Crown Prosecution Service
- Decides whether a prosecution is in the public interest
  - Investigation
  - Evidential Stage
  - Public Interest Test
- Assessment of whether there is a 'real prospect of conviction'
- Case then goes to CRIMINAL court
- Number of factors

# Euthanasia

For Prosecution	Against Prosecution
Under 18	Motivated by compassion
Lacked Capacity	Reached clear, settled and informed
Gain made by assistant	decision
Assistant was a doctor, AHP	Assistant had tried to dissuade them
Encouragement	Assistant reported the death and
History of violence between parties	fully assisted any investigation
Assistant received payment	Assistant did no more than aid
Assistant belonged to a pro	
euthansia group	

### Proposed Legislation

- Assisted Dying Bill 2014
  - Terminally ill, mentally competent adults
  - Approval by two Doctors +/- High Court Judge
  - Basis Oregon Death with Dignity Act 1997
  - Ran out of time due to 2015 election
- Assisted Dying Bill 2015
  - Private members' Bill
  - Defeated at second reading
