Launch of new e-form for reporting patient safety incidents that occur in general practice

I am delighted to inform you that the NHS England Patient Safety Domain has launched a new e-form specifically designed to make it quick and easy for general practice staff to report patient safety incidents to the NHS' national patient safety incident database, the National Reporting and Learning System (NRLS).

The NRLS currently receives over 1.5 million incident reports from healthcare professionals each year. However, these reports are almost entirely from secondary care, and the small number of reports from primary care is not reflective of the 360 million consultations each year, limiting opportunities for learning and action to improve patient safety and the quality of care.

Using the new e-form, within a few minutes practice staff will be able to confidentially submit patient safety incident reports to the NRLS. At a national level these reports enable us to identify key themes and trends, and in turn, to develop solutions to prevent the recurrence of similar incidents across the NHS. Our ambition for general practice is to create shared learning for the benefit of patients and peers, in an open and just culture that avoids blame.

The three key actions we would like to highlight to general practice are:

- Please report all patient safety incidents (clinical and non-clinical) including near misses to the NRLS, whether they cause actual harm or not

 use the new e-form to report patient safety concerns / incidents to aid national learning and receive a bounce back reflective CPD / SEA template for appraisal and revalidation. This can also be used as evidence for CQC inspections.
- 2. Save the e-form icon to your practice desktop (simply drag and drop the icon) for direct access to the e-form and rapid reporting.
- 3. Visit the new general practice patient safety web pages on the NHS England website for a comprehensive package of feedback, learning and resources for GP's and the whole team. Patient safety is everyone's responsibility and this suite of resources, including a guide to incident reporting for general practice, will help the entire practice team meet their obligation to keep patients safe from harm. It is only with the assistance of organisations like your own, that we will achieve an accurate insight into patient safety in general practice and to deliver shared learning and solutions which will be an essential tool in preventing unnecessary harm to patients and saving lives.
